2.1 Personal Information & Privacy

Explosion Technologies collects personal information from a variety of sources, including from members of the public, advertisers, mailing lists, contractors and business partners.

In general, the personal information Explosion Technologies collects includes (but is not limited to) name, address and contact details.

Explosion Technologies stores the personal information you enter on the website. Explosion Technologies obtains most personal information through the website registration process.
